Not all proposals were supported by all group members, but we agreed all should be put forward for your views.

Please take part in the consultation: It is important that a high percentage of households respond whether you support or object to the proposals.

However, the more people who support them, the more likely we are to gain action from Essex Highways and the North Essex Parking Partnership which has the final say.

The Parish Council does not have the powers but will support residents' views in lobbying and negotiating.

ROAD SAFETY

PROPOSAL Apply for a 20mph speed limit to cover the whole

of Foresthall Park. A "Twenty is Plenty" scheme just for Walson Way has been requested but even if approved by the Uttlesford Highways Panel, it is not legally enforceab.

SAFER PARKING

PROPOSAL White line some pavements to allow cars to be part parked on the path whilst allowing pedestrians and those with buggies or wheelchairs to pass safely:

PROPOSAL Create parking bays on the straight stretch of Walson Way (left hand side coming from Church Road). This would be dependent on both funding and the location of utility services.



AIRPORT PARKING

Complaints about airport parking are frequent. Preventing the nuisance is difficult.

PROPOSAL Introduce a Residents' Parking Scheme covering Foresthall Park

This is the only certain way on offer to eliminate airport parking, but comes with a direct financial cost to residents.

The scheme conditions are set by the North Essex Parking Partnership (NEPP) and negotiation unlikely. We have asked about imposing no parking for one hour a day but this was rejected as unworkable.

The scheme's main elements are:

- Any resident with a permit could park in any legal space on Foresthall Park.There are no allocated spaces.
- Enforcement by the NEPP is likely to be for 4 hours per day between 10am to 2pm Monday Friday. This should stop long-term parking.
- · Permits based on current charges would be:

Annual Residents' Permits — First Car - £70, Second Car - £120 and Third Car - £157.50

Visitor Permits — 10 x 24-hour permits - £11.50 / 6 x 6-hour permits - £6.00

Carers' Permits — Annual - £30

There are concessions for those in receipt of the higher mobility component of DLA.

Please note that if you are away from your home, with your car, during the enforcement period, you would NOT need to buy a residents' permit. Permits are also only required for spaces on the road (not driveways!).

For a scheme to proceed, it must be supported by a minimum of 75% of households.

PROPOSAL Add more signage to discourage airport parking With support from Manchester Airport Group, owners of Stansted Airport, signs discouraging airport parking have been erected, but more may be needed. These are not enforceable.
